Otherwise those selected tend not to fulfill their obligations. So, we look for volunteers who want to be involved in helping this association grow. So let us know if you want to be involved, have an idea or activity you would like to see a committee formed for, or if you would like to chair a committee.

Regrettably, Mark Wintermute recently resigned from the Board of Directors. We would like to thank Mark for his service to the BBSAI -- Thank you, Mark.

## BBSAI Promotes Blackbelly Sheep in American Sheep Industry Newsletter

The American Sheep Industry (ASI) is a national organization representing the interests of more than 69,000 sheep producers located throughout the United States. Last March, the ASI extended the BBSAI a special one-time advertising offer in the Sheep Industry News, its monthly printed publication.

# Registering Undocumented BB Sheep under the New Exceptions Policy

In the May 2008 BBSAI Newsletter, President Mark Fleming announced that the moratorium on the registration of undocumented Barbados Blackbelly sheep (in effect since March 2007) is now lifted and the new Barbados Blackbelly registration policies are now in effect. This includes 1) the closed BB registration policy, requiring that sire and dam be registered before offspring can be registered, and 2) the exceptions policy, whereby BB sheep may be registered even if their sire and dam are not registered, after approval by the exceptions policy committee. Please note that registrations of American Blackbelly (AB) sheep are not affected by these changes, and the AB registration policy still remains an open registration policy.

The BB exceptions policy committee is now in place and is ready to review registration applications for undocumented BB sheep.

The new closed BB registration policy is stated in the BBSAI Bylaws, Article X, sections C and F, and the procedures for submitting applications to register undocumented BB sheep under the new exceptions policy are stated in the BBSAI Standing Rules, Article IV, sections A and B.

To register your undocumented BB sheep under the exceptions policy, please use the regular BBSAI Sheep Registration Application (available online at <a href="www.blackbellysheep.org">www.blackbellysheep.org</a>) and submit the usual photos and \$5.00 fee per sheep. If these are undocumented BB sheep (sire and dam are not registered BB sheep), then you will also need to submit one or more additional page(s) answering all the questions shown in the Standing Rules, Article IV, section A. Please provide as much information as possible. And please sign and date that additional information, to attest that you certify this information is true.

All registration application packets, fees, and photos should be submitted to the Secretary/Treasurer, BBSAI at 815 Bell Hill Road, Cobden, IL 62920. I will review them first, and I will then forward those applications with undocumented sheep to the exceptions

policy committee for their ruling on those sheep. When the committee is done with their work, they will return their ruling and the packets to me, and I will take the appropriate action to register your sheep or return your materials to you.

When filling out the registration forms, please put sheep being registered under the exceptions policy on a separate registration form -- that is, please do not combine documented sheep with undocumented sheep on the same form -- use two separate pages. Also, any documented sheep being "tracked" should be placed on a separate form.

Vote to appoint Carol Elkins chair of the BB Exceptions Policy Committee. (5 yes, 1 abstain). Passed.


### 6/4/08

# BBSAI Annual Membership Renewals are Due July 15, 2008 & BBSAI Lifetime Members Status Update

Two important deadlines are rapidly approaching for BBSAI members. First, all BBSAI annual memberships will expire on July 15, 2008. In the past, the secretary/treasurer has mailed a membership dues renewal notice to each annual member's home. However, this year for the first time we are enclosing the membership renewal form in this newsletter, to save postage costs. Please take a moment to fill out and return this BBSAI Annual Membership Renewal form, and mail it back to the BBSAI to *preserve your membership status for the coming year*.

Additionally, this spring the Board of Directors voted to require lifetime BBSAI members to send in the BBSAI Annual Membership Renewal form in order to keep their voting status active. Lifetime members who do not complete and return this form to the BBSAI once each year will have their status changed to "inactive lifetime" status, meaning that they will not be able to vote on issues brought before the membership. Please note that lifetime members are not required to send in any money; they simply must return the Annual Membership Renewal form to maintain their voting privileges for the coming year. This procedure was enacted to help overcome the large number of inactive lifetime memberships in the BBSAI, many of whom had outdated contact information.
